FEES



ALL INCLUSIVE CARE – We want your nursery experience with us to be as easy as possible. Our all-inclusive care package includes:

Health & Hygiene: Wipes, nappy cream, nappy sacks, sun cream, emergency Nappies (you will be required to supply nappies), bed linen and emergency medications (with consent).

Food & Snacks: All meals, snacks, milk and fruit for the whole day.

Enrichment & Care: Soft play (NH), trips out, PE sessions, cookery, cultural visits, chicken/duck hatchings, Pre School projects, library books, parent engagement events, stay and play sessions, Pre School leavers party and lots more.

CHILDREN UNDER 2 CAN ONLY ACCESS OUR STRETCHED OFFER.

FUNDING – 2-5 YEAR OLDS
Your funding is allocated throughout the academic year (September-August)
You must remain on the same contract for the full academic year.

DISCOUNTS – We want to support our parents in any way we possibly can. Working in partnership with parents is a priority for our setting.
Sibling Discount: 10% is applied to your oldest child on all our fees. We have 10% discounts for Employees of Lindum Business Park NH, Lincoln University, Lincoln County Hospital and Siemens.

SPREADING THE COSTS

Stretched (all year round) – We spread the cost of your fees across the whole year; we calculate our fees on a monthly basis so that you pay the same fixed amount every month

Term Time – 38 weeks of the year with a variable monthly amount.

OPENING – We are open for 51 weeks of the year. Bank Holidays, Christmas/New Year Closures will NOT be charged for.

No refunds are given for sessions missed due to sickness, holidays, early closing on the last day of the Christmas term, unavoidable nursery closures or due to pandemics or periods of self-isolation for yourself or your child.

Please note: We require one months' notice for any changes with your care.

FUNDING 9 months – 3 years old

Here at Fun Farm Day Nursery, we are pleased to provide the Governments 15 hours and 30 hours funding.

ELIGIBILITY CRITERIA – All eligible working families may be able to access up to 30 funded hours of childcare per week starting the term after your child turns 9 months.

All children 3 years old (the term after your child 3rd birthday) are entitled to 15 hours per week.

Please note: Government funding is not intended to cover the cost of meals, other consumables, or extra-curricular activities. Consequently, as part of our all-inclusive care package, we have applied reasonable charges for these to each funded session.

- ✚ If you are considering options other than our all-inclusive offering, please speak to the Nursery Operations Manager as we have limited availability.
- ✚ For our Families who access additional support funds or Early Learning for two-year-olds (EL2) please speak with the Nursery Operations Manager on joining either of our nurseries.

30 hours funding: 30 hours Government entitlement consists of 1140 hours per year. On our stretched offer your maximum funding entitlement per week will be 22.35 hours for 51 weeks of the year. On our term time only offer it will be for 30 hours per week for 38 weeks of the year.

15 hours funding: 15 hours Government entitlement consists of 570 hours per year. On our stretched offer your maximum funding entitlement per week will be 11.18 hours for 51 weeks of the year. On our term time only offer it will be for 15 hours per week for 38 weeks of the year.

The fee sheets you have been given are effective as of the 1st April 2026 and are typically reviewed annually (and typically introduced in April) in accordance with our T&C's
